REPORT ON REFRESHER COURSE- LAW

INTRODUCTION:

The first Refresher Course in Law hosted by the state of Chhattisgarh, organized by Human Resource Development Center (HRDC), Pt. Ravi Shankar Shukla University, Raipur was held during 07th to 19th September 2020. It was also the first successfully conducted Refresher Course in Law, in the nation, on a virtual platform (Google Meet) in the view of COVID-19 pandemic.

In the course, participants joined enthusiastically from all over the country and we had a 'Mini India' on the virtual platform: from UP in the north to Karnataka in the South, from West Bengal in the East to Gujarat in the West as well as from MP, CG and Jharkhand in Central India. Out of 40, 24 participants joined from different colleges of Chhattisgarh. 7 participants joined from colleges situated in Varanasi (BHU), Lalitpur, Barabanki, Muradabad, Sultanpur and Lucknow from the state of Uttar Pradesh. 5 participants joined from the renowned National Law Universities including The West Bengal National University of Juridical Sciences, Kolkata, National University of Study and Research in Law, Ranchi, Jharkhand, Gujarat National Law University, Gandhinagar. 2 participants joined from Government College situated in Bhopal, Madhya Pradesh and 2 participants joined from Government aided college in Tumakuru, Karnataka. Out of 40 participants, 8 were female and 32 were male.

Not only participants, eminent resource persons too joined from the states all over India - right from the North i.e. Jammu & Kashmir, Punjab, Haryana and New Delhi to Andhra Pradesh and Telangana in the South; from Gujarat and Rajasthan in the West to Odisha, Bihar and West Bengal in the East; and also, from M.P. and C.G. i.e. the heart of India (Central India).

INAUGURATION:

The inaugural session began sharp at 10:30 am on 7th September 2020. The Director of HRDC, Dr. Ashwini Kumar Gupta and Assistant Director of HRDC, Dr. Brijendra Pandey addressed the participants about the course overview. Each of the 40 participants of the course introduced themselves. The Course Co-ordinator, Dr. Vineeta Agrawal welcomed the participants and highlighted the framework of the course. On the second day, Vice Chancellor of Pt. RSU, Dr. K.L. Verma motivated the participants and the organizing team with his words of wisdom. The lecture schedule of resource persons along with chairpersons and reporters list enclosed. Each lecture of 60 minutes was followed by 30 minutes of active interaction and discussion by participants.

REFRESHER COURSE SESSIONS:

We were privileged to connect WITH 35 resource persons over a period of 12 days.

6 lectures were delivered by Vice Chancellors (VC) of various Universities (including National Law Universities), who enlightened us with their wisdom on current topics that included:

1. & 2. **Prof. (Dr.) Sanjeevi Shantha Kumar, VC, Gujarat National Law University, Gandhinagar, Gujarat** covered the topic **Teaching Environmental Law**. He spoke at length on various teaching methodology and their applications. He showed the participants the way to move beyond pedagogic teaching. In his second session on **Evolution of International Environmental Law** covered the topic by dividing it into 3 distinct periods:

- a) Traditional period
- b) Modern period
- c) Postmodern period

3. **New Education Policy** by **Prof (Dr.) Surya Prakash, VC, DS National Law University, Vishakhapatnam, A.P.** where he emphasized on innovative research and practical outlook of teaching to bring out the best in the students.

4. **Criminal Justice System in India** by **Prof. (Dr.) MehrajUddin Mir, VC, Central University of Kashmir, Shrinagar, Jammu & Kashmir** where he highlighted the current scenario of Indian criminal system with recent Supreme Court cases and presented his views on article 370 in the State of Jammu and Kashmir.

5. **Separation of Power and Constitution of India** by **Prof. (Dr.) Vijaya Kumar, National Law University, Bhopal, M.P.** session covered the broad spectrum of the constitution of USA and Great Britain regarding their influence on Indian Constitution.

6. **Juvenile justice** by **Prof. (Dr.) Viney KapoorMehra, VC, Dr. B.R. Ambedkar National Law University, Sonipat, Haryana** with her vast expertise and experience on the topic, she started the discussion from a historical perspective and mentioned that we still need to discuss the condition of children in context of POCSO Act, 2012

Few other highly relevant hot topics covered by resource persons from National Law Universities are as follows:

1. **Intermediaries Liability and Social Media-Emerging Issues and Challenges** by **Prof. (Dr.) Anand Pawar, Professor, Rajeev Gandhi National University of Law, Patiala, Punjab** started with highlighting how we are not trained in this area and concluded with tips to deal with it.

2. **COVID-19 Pandemic and Role of Higher Judiciary** by **Prof. (Dr.) Dipak Das, Professor, Hidayatullah National Law University, Raipur (C.G.)** highlighted that present role of judiciary may not be fruitful and discussed his valuable suggestions where all participants actively voiced their opinions.

3., 4. **Understanding Plagiarism and its Dangers in Research and Constitutional Challenges in the 21st Century** by **Prof. (Dr.) Ajay Kumar, Dean (Academic Affairs and Law), Chanakya National Law University, Patna (Bihar)**. In the former session he

elaborated about research which would be of great help in carrying out research projects and in the latter, he highlighted about the challenges posed to our Constitution in this era of awakening.

5. Constitutional Philosophy of Fundamental Duties by **Dr. Deepak Srivastav, I/C Registrar HNLU, Raipur (C.G)** emphasized the importance of 11 Fundamental Duties and inspired each one to work towards fulfilling them.

Other highly relevant, current challenges of national debate which were covered by lectures of experts included:

1. **Equal rights of daughter Under Hindu Succession Act** by **Prof. (Dr.) Rakesh Singh, Lucknow University** that was based on Supreme Court statement which is as recent as 11 August 2020.
2. **Computer Related Crimes** by **Prof. (Dr.) Archana Ranka, DAVV, Indore** which is on all-time peak with tremendous increase in technological advancements.
3. **Freedom of Speech and Expression** by **Prof. (Dr.) Rattan Singh, Chandigarh University**, which needs to be understood better to avoid the misuse.
4. **Right to Health** by **Prof. (Dr.) Manoj Sinha, Director, ILI, New Delhi**, that has emerged as a crucial avenue in critical pandemic times.
5. **Combating Human Trafficking in India** by **Prof. (Dr.) Sarfaraz Ahmed Khan, Symbiosis Law School, Hyderabad** started with the known case of Nadia Sultana from Bangladesh who Committed Suicide in a jail in India. He described the issue in detail which is a huge underlying problem of the nation

Some other challenging issues raised by resource persons from State Government institutes included:

1. **Water Legislation** by **Prof. (Dr.) N KayalVizhi, Principal, Government College, Villupurum, Tamil Nadu** highlighted the status of human rights to water and water rights in India. She broadly covered water security problem, virtual water concept, role of NITI AAYOG, key water challenges, water Acts and environmental law principles.
2. **Gender Equality and Gender Justice** along with **Article 21 and Human Rights** were covered by **Prof. (Dr.) Nisha Dube, Barkatullah University, Bhopal, MP**. In her former session, she spoke about the mindset of the people, gender equality and women empowerment after 70 years of Independence with recent Supreme Court judgements. The latter session was also supplemented by famous leading cases.

Legal Research Methodology was covered in 3 sessions by:

1. **Prof. (Dr.) Rajnish Singh, BHU, Varanasi** discussed the difference between **Copyright and Plagiarism** and how Plagiarism, that is controlled by UGC regulations of 2018, can be avoided in research papers.
2. **Prof. (Dr.) Prabir Kumar Pattnaik, Siksha O Anusandhan University, Bhubaneshwar, Odisha**, elaborated Legal research Methodology in which he described research, differentiating code of ethics and morality while undertaking creative writing, concept of fair use and 11 types of legal research with interpretations.
3. **Prof. (Dr.) Mona Purohit, Dean, Barkatullah University** talked on **Research and IPR** with engaging powerpoint presentation.

Other challenging yet interesting issues covered were:

1. **Uniform Civil Code in India** was covered by **Prof. Yogesh Sharma, Jaipur University, Rajasthan** with special inputs on the challenges on the way.
2. **Anti-Defection Law** was discussed by **Prof. Devinder Singh, Punjab University, Chandigarh** along with its implementation and recent development.

3. **Assessing Environmental Ethos in India's Enviro-Legal Governance** was talked on extensively by **Prof. (Dr.) Amar Pal Singh, GGS IPU, New Delhi.**
4. **Clinical Legal Education and University Legal Aid Clinics in Securing Rights of Persons in Custody** was covered by **Madhurima Dhanuka, Program Head, Prison reforms, New Delhi** with descriptive presentation.

Relevant subtopics on Justice and Judiciary highlighted by experts were:

1. **Social Justice** and **Natural Justice** were covered in depth by **Prof. (Dr.) SK Gupta, BHU, Varanasi** and by **Dr. Binay Das, Utkal University, Bhubaneswar**, respectively.
2. **Equal Access to Justice in India** was dealt by **Prof. KPS Mahalwar, NLU, New Delhi** which is surely a point worth discussing in nation's interest.
3. **Judicial Review: Current approaches in India and COVID 19 & Legislative Measures** were covered by **Dr. Anurag Deep, IIL, New Delhi** using comprehensive powerpoint presentations.
4. **Law and Justice** was well explained with differentiating features by **Prof. (Dr.) Uday Shankar, IIT, Kharagpur, WB.**

We were extremely fortunate to hear from an International Resource person Prof. Irene Calboli, from the Texas University, USA and exchange ideas overseas on the topic 'Trademark Protection'. In this lecture, functions of trademark were highlighted. Sources of trademark protection and major international instruments were explained. Trademark protection was emphasized; hence, students should be involved in it by way of practical exercises. The focus on the session was to convey teaching methods to be adopted while covering trademark in lucid language.

Participants submitted duly filled feedback forms for each session which revealed that they were extremely satisfied with the content and methods of lecture delivery. Punctuality was maintained throughout the course for each session. We were fortunate to have no technical issues that could have hampered the smooth running. All sessions were interesting, informative and engaging.

In toto, we had an amalgamation of experts who presented their views through powerpoint presentations, lectures and discussions on legal aspects of the hot topics of discussion not only in India but globally. Thus, it completely fulfilled the purpose of the course and lived up to its theme.

ASSIGNMENTS BY PARTICIPANTS:

The participants whole heartedly completed all assignments including:

1. **Microteaching:** For this, participants included the topics of their interests from syllabi of law colleges that were fitting into the theme of the course.
2. **Panel discussions:** It turned out to be exciting and fruitful means of delving in current topics of national interest that included:
 - a. **Mob Lynching**
 - b. **Fake Encounters and Rule of Law**
 - c. **Contempt of Court**
3. **Seminar:** These were presented by participants through means of powerpoint presentations along with abstracts on current legal issues.
4. **Chairing and Reporting:** The participants successfully performed their duties as Chairpersons as well as of reporting the sessions.

All the above 4 assignments were conducted under the keen supervision of esteemed resource persons Dr. Sudhansu Ranjan Mohapatra from Sambalpur (Odisha), Prof. S.N. Sharma from Ujjain (M.P.), Prof CL Patel from Raipur and Dr.BP Yadav from Raigarh (C.G.),who provided their valuable suggestions and assessed the participants.

5. **MCQ Ending Test:** The course was concluded with MCQ test through Google forms. 30 questions related to the content covered in the course were asked in which all participants came up with flying colours with score range between 20-30 out of a total of 30 marks.

After cumulative evaluation based on above4 assignments and MCQ test, all participants achieved either Grade A or Grade A+ which is rewarding for each of us as organizing team too.

VALEDICTORY CEREMONY:

In the Valedictory cum closing ceremony, respected Vice Chancellor of Pt. RSU, Dr. KL Verma addressed and congratulated all participants for successful completion of the course. Director, HRDC, Dr. Ashwini Kumar Gupta and Assistant Director, Dr. BrijendraPandey addressed, moderated feedback from each participant and awarded certificates online (sent via email). All participants were content with the organization of the course and highly praised the efforts of the team. The expressed gratitude for upgrading of their knowledge and ensure that it would reflect in their teaching as well as research for the benefit of the students and society as a whole. The essence of New Education Policy is practical based learning that is research and innovation oriented. The participants remarked that the spark of curiosity has been ignited by this course that will go a long way to bring out the creativity which would fulfill the purpose the NEP 2020 to a great extent.

In the concluding note, the Course Coordinator, Dr. Vineeta Agrawal thanked respected VC of Pt. RSU, Director and Assistant Director HRDC, technical staff of HRDC, all eminent resource persons and participants for their fullest cooperation and support. With

her motivational words to continue learning and growing, the event that witnessed a grand success ended with an intent to stay connected!

SWOT ANALYSIS:

Strengths:

1. **Successful completion** of refresher course in law itself is a huge strength.
2. The course had participants from all corners of India as well as heart of India, **making it atruly national course.**
3. Tremendously renowned and eminent law readers from India as well as USA who connected without any technical issue, **giving it an International hue.**
4. Virtual platform provided the ease of attending the refresher course for participants and for resource persons from the comfort of their native place without the cost and risk of travelling in the era of pandemic (**COVID 19 here turned out to be a 'Blessing in Disguise'!**)

Weakness:

1. We could not have audiovisual recording of the sessions.
2. Due to time constraints, some current challenging legal issues could not be touched.
3. Physical presence adds a personal touch in establishing long term relationships which is lacking in online meetings.

Observations:

1. Use of Virtual Platform brings with it, its own unique challenges which were overcome by HRDC, Pt. RSU, Raipur.
2. RC in law is seldom organized which should be more frequent. It should be undertaken not only for career advancement but also for updating knowledge and exchange of ideas as **law is considered to be a part of social engineering**

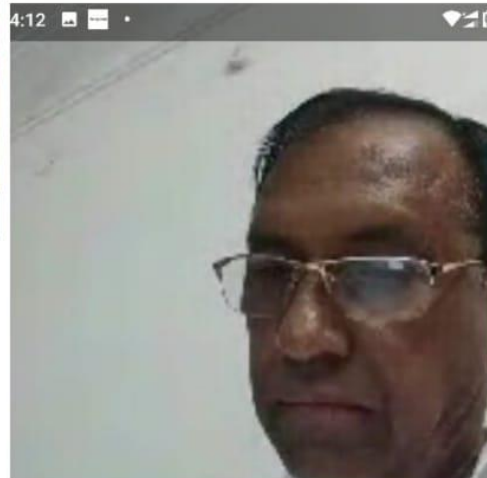
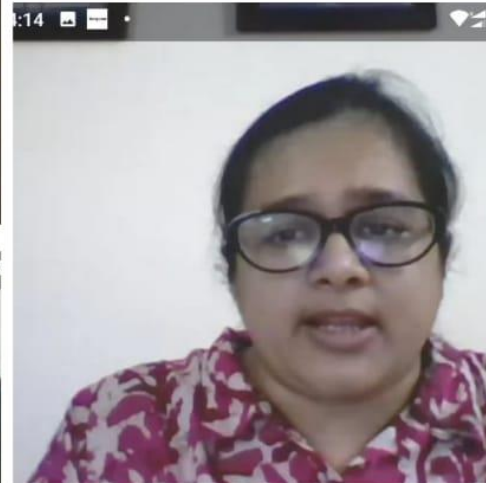
