### Courses Offered

1. B.A.LL.B. (Five Years, 10 semesters)

Eligibility :- An applicant who has passed & successfully completed Senior secondary school certificate course in 10+2 system or equivalent (such as 11+1, 'A' level in senior school leaving certificate) course recognized by the university or passed Higher Secondary School Examination of Chhattisgarh Board of Higher Secondary Examination, Raipur with at least 45% of the total marks in case of General category and 40% of the total marks in the case of SC and ST in any stream and also fulfilled the other institutional and State Government criteria shall be eligible for a admission in B.A.LL.B First Semester. The procedure for this admission shall be announced by the University administration every year

2. LL.M. (Two years, four Semesters)

Eligibility: - A Candidate who after having passed the three years course for the degree of Bachelor of Laws of the University or of any other statutory University recognised as equivalent thereto, with at least 55% of marks (in case of ST/SC/OBC candidate 50% of the marks LL.B. or equivalent Examination) has prosecuted a regular course of prescribed study for one Semester session in the University Department of Law or any college affiliated to the University shall be eligible to appear at the LL.M. Part-I, First Semester Examination.

3. Doctor of Philosophy in Law

Eligibility:- As per University Ordinance

### Age Limit & Reservation

(A) Age: The maximum age limit for seeking admission into a stream of integrated Bachelor of Law Degree Programme, is limited to Twenty Years in case of general category of applicants and Twenty-two Years in case of applicants from SC, ST and Other Backward Communities.

(B) Reservation : 12% seats for Scheduled Castes, 32% seats for Scheduled Tribes, 14% seats for Other Backward Classes and 3% seats for the Physically Handicapped are reserved (Except Physical Education). 3% seats for the dependents of the freedom fighters are reserved as per the rules of the Chhattisgarh State. If seats for the aforesaid categories are vacant, then they will be allotted to other eligible applicants. Out of all these categories 30% seats are reserved for women applicants. It is necessary to attach certificates from competent authority along with the application for reserved seats. (Note-Subject to change as per C.G. Government)
