छत्तीसगढ़ शासन, उच्च शिक्षा विभाग, मंत्रालय के पत्र क्रमांक एफ 3-18/2023/38-2 दिनांक 05.10.2023 के परिपालन में दो विषयों में अनुत्तीर्ण विद्यार्थियों को पूरक की पात्रता देने के लिए केवल सत्र 2022-23 के लिए दो विषयों में पूरक का अवसर प्रदान करने के संबंध में अध्यादेश क्रमांक-6, 12 एवं 110 में निम्नानुसार संशोधन को अधिसूचित किया जाता है -

Ordinance No. 6	Nil	<p>38 This Special Clause is being added in the Ordinance to define the Eligibility for appearing in the Supplementary Examination of the Session 2022-23. This Clause shall be applicable only for the Session 2022-23 and not be treated as paradigm or example for any session other than 2022-23:-</p> <p>(1) (a) Candidates who have failed at any B.A., B.Sc, B.H.Sc., or B.Com. Examination in not more than two subjects or group as case may be.</p> <p>(b) Candidate for examinations other than those enumerated in (a) above who are declared eligible to appear at a supplementary examination in accordance with the Provision of the respective examination ordinance.</p> <p>(2) In the case of a subject for supplementary examination in which there is also a practical test, a candidate shall be required to appear in the written paper only if he/she has passed at the main examination in practicals and in practicals only if he/she has passed in the written papers and practicals shall be examined in both the parts of the subject.</p> <p>(3) Except when provided otherwise in the ordinance concerned, a candidate who has been declared eligible for a supplementary examination may appear as a supplementary Examination Candidate in the two examinations immediately following the examination in which he was declared to be so eligible and thereafter he/she shall be required to appear in all the papers at the next examination.</p> <p>(4) A candidate appearing in the Supplementary examination shall be declared to have passed the examination if he/she secures the minimum passing marks in the subject as the case may be except when provided otherwise in the examination ordinance concerned. Such a candidate shall be deemed to have obtained only the minimum passing marks in the subject as the case may be and such minimum</p>

		<p>passing marks shall be taken in to account in determining the division at the examination.</p> <p>(5) Such candidates as are eligible to appear in the second examination may be provisionally admitted in the next higher class in University Teaching Department, School of Studies or College and their attendance in the higher class shall be counted in case they are declared successful at the second examination. If the candidate fails at the examination, the admission to the higher class shall be cancelled and the candidate shall revert to the lower class.</p>
Ordinance No. 12	Nil	<p>11 This Special Clause is being added in the Ordinance to define the Eligibility for appearing in the Supplementary Examination of the Session 2022-23. This Clause shall be applicable only for the Session 2022-23 and not be treated as paradigm or example for any session other than 2022-23:-</p> <p>Candidates will have to pass separately to the B.A. Classics Part I, Part - II and Part- III examinations. No division shall be assigned on the result of Part - I and Part-II examination. The division in which a candidate is placed at the Final examination shall be determined on the basis of the aggregate of total marks obtained in the Part -I, Part II and Part - III examinations.</p> <p>Provided in case of a candidate who has passed the B.A Classics Part - I and Part - II examination through the supplementary examination having failed in two subject only, the total aggregate marks for being carried over for determining the division shall include actual marks obtained in the subject in which he appeared at the supplementary examination.</p>
Ordinance No. 110	Nil	<p>13 This Special Clause is being added in the Ordinance to define the Eligibility for appearing in the Supplementary Examination of the Session 2022-23. This Clause shall be applicable only for the Session 2022-23 and not be treated as paradigm or example for any session other than 2022-23:-</p> <p>13.1 A candidate failing in two theory paper of BPE-I, II, III and IV examination shall be eligible to appear in supplementary examination in the paper in which he/she has failed, to be conducted in the month of September and shall appear only in that paper. Such candidates shall be eligible to be admitted in the next higher class, if he/she fail in the supplementary examination he/she may take another supplementary examination alongwith the annual examination of the next higher class, if he/she however, fails in the second supplementary also his/her result of the higher class will be cancelled and he/she shall have to appear a fresh in all the papers in the respective lower examination in the subsequent examination and shall</p>



		<p>be allowed to appear in the higher examination only when passed lower examination in full.</p> <p>13.2 A candidate, who fails in more than two theory subjects or in aggregate of activity/teaching practice/sports specialisation shall be declared failed and shall not be eligible to join the next higher class or the same class in that academic year. He must appear in the exam as an ex-student along with other regular students.</p> <p>13.3 A student failing in any one of the parts shall be allowed to appear as ex-student in the annual examination in the respective parts only in which he has failed and his sessional marks, if any previously obtained shall be carried over. A student who fails in sessional in any of the parts shall be declared failed and shall make up sessional in the Part in which he has failed in the subsequent year as to be notified by the institute. He will not be eligible to take admission in higher class till he makes up his sessionals.</p> <p>13.4 At the end of BPE final exam each successful candidate shall receive a detailed marksheet in addition to his degree.</p>
