**Ordinance No: 171(Revised)**

**Master of Arts  
In  
Applied Philosophy and Yoga**

1. The degree of Master of Arts in "Applied Philosophy and Yoga" shall be of Four Semesters (Two academic years) duration.

2. **Course content** : Every semester will comprise of Four papers and every paper will be of 100 marks. There shall be Three theory and One Practical (Yoga Practice) paper in semester One, Two and Three. In fourth semester there shall be two theory papers only. Third paper of fourth semester shall be divided into Two parts—i. Project work of 75 marks and ii. Teaching practice of 25 marks only. Fourth paper of fourth semester shall be of Advanced Yogic Practices of 100 marks. Course content shall be revised as per need by the Board of Studies of Philosophy at times.

3. **Admission Eligibility:** *Graduate in any discipline.* Admission will be given on merit basis. Oral or written test if necessary will be conducted by the School of Studies. Since it is a Health (mental and Physical) oriented and professional course of applied philosophy maximum age limit for admission to the course shall be 40 years.

*Age relaxation for employees, shall be as per the guideline of directorate, Higher Education, C.G.. Govt.*

4. **Examination:** The examination of the course shall be conducted by Pt. Ravishankar Shukla University, Raipur. The division will be awarded by the University as per its existing rules. Minimum passing marks will be 36 percent in theory and 50 percent in Practical (Yoga Practice) separately. Every paper of each Semester shall consist 100 marks.

*A student failing to appear or securing less than 36% aggregate or obtaining less than 20% marks in any of the theory course of I, II & III semester examinations shall be allowed to pursue the courses for the next following semester. Such students shall have fail or fail in aggregate (With ATKT) or ATKT status in I, II, III or IV semesters and their scheme of examination shall be as follows:*

- (i) *A student failing to qualify the examinations of I and II (odd semesters) And II and IV (even semesters) shall be permitted to appear in the ATKT /re-examination along with the following odd or even semester exami-*

- (ii) *A student failing to qualify ATKT/reexamination of I semester shall be declared fail and his/her III semester examination shall be cancelled*
- (iii) *A student failing to qualify ATKT/reexamination of II semester shall be declared fail and his/her IV semester examinations shall be cancelled.*
- (iv) *A student failing to qualify ATKT/reexamination of III semester shall be declared fail and his/her IV semester examination shall be cancelled.*

*A student who has failed in ATKT/reexamination shall reappear as ex-student.*

*The matters not covered by this Ordinance shall be governed by the Ordinance 05, 06, 170 and other provisions of the university rules.*
