छत्तीसगढ़ शासन, उच्च शिक्षा विभाग, मंत्रालय के पत्र क्रमांक एफ 3-38/2020/38-2 दिनांक 11.01.2021 में प्राप्त अनुमोदन अनुसार विश्वविद्यालय के नवीन अध्यादेश क्रमांक-194- P. G. Diploma in Applied Hydrogeology में निम्नानुसार अधिसूचित किया जाता है -

Ordinance No. 194

P. G. Diploma in Applied Hydrogeology

(E.C. under 25-07-2019)

1. The duration of the P. G. Diploma in Applied Hydrogeology shall be of one academic year, as per the Memorandum of Understanding between Pt. Ravishankar Shukla University with Rajiv Gandhi National Ground Water Training & Research Institute, CGWB, Raipur.
2. A candidate, after obtaining the Masters Degree in any of the following disciplines namely, Geology, Applied Geology, Environmental Science, or Bachelors Degree in Civil Engineering of this university or any statutory university in India, which has been recognized by the university or, equivalent to the above mentioned degree of the university, is an eligible applicant.
3. The admission to the P. G. Diploma in Applied Hydrogeology shall be on the basis of an Entrance Test. The date of the entrance test shall be decided and published by the university. The admission list will be prepared, as a sum total of the marks, scored in the entrance test (40%), those in the respective degree examination (40%) and based on personal interview (20%). The admission rules, pertaining to Reservation, shall be applicable as per the University norms.
4. The duration of PG Diploma in Remote Sensing & Geographic Information System is **One (01) Academic Year**, with yearly examination pattern. The course structure and Syllabus along with the Scheme of Examination shall be as prescribed by the Board of Studies in Geology.
5. The candidate, admitted to the P. G. Diploma in Applied Hydrogeology, has to attend and complete a regular course of study for one academic year in the School of Studies in Geology and Water Resource Management and as per the Memorandum of Understanding between Pt. Ravishankar Shukla University with Rajiv Gandhi National Ground Water Training & Research Institute, CGWB, Raipur.
6. The practical examination shall be conducted at the School of Studies in Geology and Water Resource Management and the theory examination by the University, as per the University norms.
7. The passing marks for each theory paper, practical and dissertation shall be 33%. A candidate shall be declared successful if he/she obtains at least 40% marks in aggregate, including Theory, Practical and Dissertation. A candidate is required to pass in the practical and theory examinations, by obtaining a minimum of 40% marks, separately.
8. The declaration of examination result shall be as follows:
 - a. Passing Marks for each paper shall be 33%;

- b. Those candidates who have secured at least 40% marks in aggregate (including Theory, Practical and Dissertation) shall be declared successful in the examination;
 - c. A candidate obtaining more than 60% marks in the total aggregate shall be declared to have passed in First Division; less than 60% but more than 50% in Second Division; less than 50% but more than 40% in Third Division.
9. An examinee who fails in any of **one** (01) subject either theory, practical or dissertation may appear in that subject without being required to attend the further course of regular study in the next examination, on payment of the examination fee, as prescribed by the University. If a candidate who appeared and failed at the theory or practical examination shall be eligible to appear as an Ex-student and shall be exempted to submit Dissertation Report again or to appear in any internal paper / practical if he has passed the same. Marks of the project report/internal papers shall be carried over for determining the result. If the candidate does not appear/ clear the subjects in the next two consecutive exams, he will lose his claim, and has to seek readmission.
 10. The provision for revaluation is available in one (01) theory paper, and the provision for re-totaling is available in two (02) theory papers, after payment of the prescribed fee as per the University norms.
 11. The provision of Grace Marks is covered as per the Ordinance 6 of the Pt. Ravishankar Shukla University, Raipur.
 12. Other provisions, not covered herein, shall be as per the University Ordinances No. 5 and 6.
