Guidelines Related to Ph.D and Ph.D. Course Work

It is hereby notified that the following clarifications have been resolved in the meeting (dated 16 September 2011) of HoD's, all SoS Pt. R.S.U. Raipur :-

- All M.Phil. students of this or any other recognized University will be exempted from the course work, provided they studied Research Methodology paper in their curriculum [Amended 45(3)(c)(ii)(b) vide Notification No. 3363/Acad/2011; Raipur, dated 19/04/2011].
- All Ph.D. students with M.Phil. degree, registered after July 11, 2009 in accordance with the old Ph.D. 2. Ordinance, will be exempted from the Ph.D. course work, provided they studied Research Methodology paper in their curriculum. Recommendation of the DRC will be final in case of any ambiguity.
- All Ph.D. students, without M.Phil. degree, registered, after July 11, 2009 in accordance with the old 3. Ph.D. Ordinance are advised to undergo Ph.D. course work. However, the course work is not mandatory for those candidates who have submitted their Ph.D. summary/thesis.
- The attendance in the course work will be as per the University ruled for other courses. This implies that 4. a Pre-Ph.D. student will have to earn 75% attendance during his/her course work.
- 5. All Ph.D. students already registered for the Ph.D. degree in accordance with the old Ph.D Ordinance shall have to pay the half-yearly tuition fee of Rs. 7500.00 and Rs. 5000.00, respectively with/without lab work from prospective due dates of payment of fees.
- Seventy percent (70%) of the half-yearly tuition fees collected from the Ph.D. students, by the research 6. centers located outside the University Campus, shall be deposited in the University. The remaining 30% shall remain at the disposal of the research center.
- 7. The teachers of the Research Center involved in the teaching program of the Ph.D. course work shall not be entitled for any remuneration/honorarium. However, remuneration/honorarium may be paid to the guest faculty as per the University rules.
- As per the revised Ordinance 45 and 52, it is mandatory on the part of all Ph.D. and M.Phil. students to 8. submit an electronic copy (in pdf format) of their thesis/dissertation at the time of submission.
- 9. A student will be allowed by the DRC to carry out Ph.D. course work in a recognised center other than the center where he/she has been registered, but in that case 30% of the half-yearly fees (for the duration of the course work only) will be transferred to the center, where he/she desires to undertake the Ph.D. course work. In case of complete transfer of a research student from the original center to another recognized research center, with the permission of the DRC, the entire fees will be transferred to the latter center. However, the transfer will be operational between centers located within the jurisdiction of the University.
